Chair Harris called the executive session of the School Committee to order at 10:13 PM and he then turned the meeting over to Interim Superintendent Gasbarro. Interim Superintendent Gasbarro reminded the School Committee that his current contract expires on June 30, 2013, and he told the School Committee he is willing to stay on as Interim Superintendent of Schools beyond June 30, 2013, if that is the wish of the School Committee, expecting his services would no longer be needed after the end of this calendar year. Interim Superintendent Gasbarro encouraged the School Committee to conduct a search for the next Superintendent of Schools. He explained that since the naming of a new Superintendent of Schools did not result from the search conducted in the winter/spring of 2013, the Massachusetts Association of School Committees is committed to continue to assist the District and the School Committee with the search for a new superintendent, should that be what the School Committee decides. Interim Superintendent Gasbarro's suggestion would be to begin a new search in September. There was general discussion about plans for the future staffing of the District's executive staff. Member Remillard asked for confirmation that Interim Superintendent Gasbarro is willing to serve as Interim Superintendent of Schools until December 2013,

assuming his services will no longer be required by the first of year. Interim Superintendent Gasbarro confirmed.
