Chair Harris called Executive Session II of the School Committee to order at 9:30 PM and he then turned the meeting over to Interim Superintendent Gasbarro, who asked that Director of Human Resources Sullivan provide historical information about the Massachusetts School Building Authority requirements regarding reimbursement for school construction and the need for inter-municipal agreements between the District and Member Towns. She explained that upon completion of debt payments for school construction projects, the town(s) must convey the school(s) to the District for \$1. The question was asked about who “owns” the land (Member Town or District), to which Director Sullivan gave the history of the District purchase of the vacant Jefferson School building, not including the fields. Member Kelley stressed the need to keep these executive session discussions confidential. Member Witkes would like clarification of liability if the District “owns” the buildings/schools. Chair Harris commented getting a legal opinion might be warranted.

Motion: To adjourn Executive Session II, to return to executive session discuss negotiations with non-union personnel, Interim Superintendent, not to return to public session.
