Chair Watson called the executive session of the School Committee to order at 8:42 PM and turned the meeting over to Superintendent Pandiscio. Superintendent Pandiscio told the Committee of his plans to modify a principal's contract, a matter which the School Committee would not typically be involved with. He wanted to keep the Committee apprised of his plans for principal assignments at Mountview Middle School in Holden and Central Tree Middle School in Rutland, in light of the upcoming retirement (June 30, 2010) of Mountview Middle School Principal Preston Shaw. The Superintendent will be reassigning Central Tree Middle School's current principal, C. Erik Githmark, to the principal position at Mountview Middle School. The Superintendent wanted the Committee to know of this plan before January 19, 2010, when Mountview Middle School and Central Tree Middle School will both hold meetings, with their staffs and with their parent groups (School Council and parent/teacher), to inform the Mountview and Central Tree communities of these changes. The Superintendent will continue to keep the School Committee informed as this process progresses.
